Diocese of Easton Day in the Marsh-April 27th 9am to 12pm at the Blackwater Wildlife Refuge in Cambridge, MD. Join others from Diocese of Easton parishes on April 27th for a day in the marsh. The day will begin indoors with prayerful meditation led by Rev. Michael Moyer and a brief introduction to marshes led by naturalists of Pickering Creek Audubon Center, followed by a hands-on exploration of the marshes of Blackwater Wildlife Refuge.
